



Bright Horizons Family Solutions Announces Pricing of Secondary Offering

WATERTOWN, Mass., Dec. 11, 2014 /PRNewswire/ -- Bright Horizons Family Solutions Inc. (NYSE: BFAM) (the "Company") today announced the pricing of the previously announced underwritten public offering by certain of its stockholders (the "Selling Stockholders") of 8,000,000 shares of its common stock at a price to the public of \$45.00 per share. The Company has agreed to repurchase from the underwriter 4,500,000 shares of the 8,000,000 shares of common stock being sold by the Selling Stockholders at a per-share purchase price equal to the price payable by the underwriter to the Selling Stockholders. As such, only 3,500,000 shares of the 8,000,000 shares of common stock being sold by the Selling Stockholders will be sold to the public. The Selling Stockholders will receive all of the net proceeds from this offering. No shares are being sold by the Company.

Barclays is acting as underwriter for the offering.

Following completion of this offering, investment funds affiliated with Bain Capital Partners, LLC will own less than 50% of the total voting power of the Company and, as a result, the Company will cease to be a controlled company under New York Stock Exchange rules.

An automatic shelf registration statement (including a prospectus) relating to the offering of common stock was filed with the Securities and Exchange Commission ("SEC") on March 25, 2014 and became effective upon filing.
